1. It is understood David Dadekian is the exclusive official photographer retained to perform the photographic and/or video services requested on this Contract.
2. David Dadekian may substitute another photographer to take the photographs in the event of David Dadekian's illness or of scheduling conflicts. In the event of such substitution, David Dadekian warrants that the photographer taking the photographs or video shall be a competent professional.
3. No part of any order, including previews, will be delivered until the balance is paid in full.
4. David Dadekian reserves the right to use negatives and/or reproductions for advertising, display, publication or other purposes. Negatives and previews remain the exclusive property of David Dadekian.
5. Upon signature, David Dadekian shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, unless Dadekian is able to fully replace the cancelled reservation, all deposits/reservation fees are non-refundable, even if the date of the wedding is changed or wedding is cancelled for any reason.
6. If David Dadekian cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Dadekian's illness or emergency, then Dadekian shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Dadekian. In the event David Dadekian fails to perform for any other reason, Dadekian shall not be liable for any amount in excess of the retail value of the Client's order.
7. Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases David Dadekian from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
8. The charges in this Contract are based on David Dadekian's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
9. NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs or videos elsewhere without David Dadekian's permission, and violators of this Federal Law will be subject to its civil and criminal penalties.
10. It is your responsibility to get permission of sanctuary, and/or officials for us to photograph the ceremony. Retainers are non-refundable if officials prohibit photography. Dadekian will most certainly abide by the rules of the sanctuary regarding camera location and use of lighting and/or flash at ceremony.
11. David Dadekian and any assistants will be provided a full entrée at reception.
12. This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
